## Marathon Gold Publishes First Annual Sustainability Report

TORONTO, July 28, 2022 (GLOBE NEWSWIRE) -- Marathon Gold Corporation ("Marathon" or the "Company"; TSX: MOZ) is pleased to report the publication of the Company's first Sustainability Report (the "Report") covering the years 2019 – 2021 for Valentine Gold Project (the "Project") in the central region of Newfoundland and Labrador ("NL").

Matt Manson, President, and CEO commented "I am very pleased to be introducing this inaugural Sustainability Report for the Valentine Gold Project. Valentine is on track to be the largest gold mining operation in the Atlantic Canada region, with a significant economic and social impact on the central region of Newfoundland. This brings a special responsibility to conduct our business with the proper focus on environmental and social protection, including the water, land, air and wildlife in the region of the Project, and the health and well being of the communities and people of central Newfoundland. This Report covers the reporting period of 2019-2021, during which time we conducted what will have been a three-year process of federal and provincial environmental assessment, conducted comprehensive environmental and social impact studies with associated management plans, presented the business investment case for the Project, pursued successful exploration programs, entered into cooperation and engagement agreements with communities and First Nations, invested in local infrastructure and community health initiatives, and developed our NL-based project development team. Our first annual Sustainability Report describes the approach we plan to take going forward in developing a successful mining business at Valentine Lake, based upon our values of Respect, Accountability, Transparency, Inclusion and Prosperity."

## **About Marathon**

Marathon (TSX:MOZ) is a Toronto based gold company advancing its 100%-owned Valentine Gold Project located in the central region of Newfoundland and Labrador, one of the top mining jurisdictions in the world. The Project comprises a series of five mineralized deposits along a 20-kilometre system. An April 2021 Feasibility Study outlined an open-pit mining and conventional milling operation over a thirteen-year mine life with a 31.5% after-tax rate of return. The Project has estimated Proven Mineral Reserves of 1.40 Moz (29.68 Mt at 1.46 g/t) and Probable Mineral Reserves of 0.65 Moz (17.38 Mt at 1.17 g/t).
